### **Personal data that we process**

VAN ROSSUM GLOBAL INDUSTRIES processes your personal data by using our services and / or by providing it to us.

Below is an overview of the personal data we process:

- E-mail address
- IP address
- Other personal data that you actively provide, for example by creating a profile on this website, in correspondence and by telephone
- Information about your activities on our website
- Data about your surfing behavior across various websites (e.g. because this company is part of an advertising network)
- Internet browser and device type

### **Special and / or sensitive personal data that we process**

Our website and / or service does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. However, we cannot check if a visitor is older than 16. We encourage parents to be involved in the online activities of their children, in order to prevent data about children being collected without parental consent. ### **For what purpose and on what basis we process personal data**

VAN ROSSUM GLOBAL INDUSTRIES processes your personal data for the following purposes:

- Give you the opportunity to create an account
- To deliver goods and services to you
- VAN ROSSUM GLOBAL INDUSTRIES also processes personal data if we are legally obliged to do so, such as information that we need for our tax return.

### **Automated decision-making**

VAN ROSSUM GLOBAL INDUSTRIES does not make decisions based on automated processing on matters that can have (significant) consequences for people. These are decisions taken by computer programs or systems, without involving a person (for example, an employee of VAN ROSSUM GLOBAL INDUSTRIES).

### **How long we store personal data**

VAN ROSSUM GLOBAL INDUSTRIES does not store your personal data longer than is strictly necessary to realize the purposes for which your data is collected. VAN ROSSUM GLOBAL INDUSTRIES uses a retention period of two years for this personal data after the commercial or email relationship with you has ended.

### **Sharing personal data with third parties**

VAN ROSSUM GLOBAL INDUSTRIES will not sell your information to third parties and will only provide this information if this is necessary for the execution of our agreement with you or to comply with a legal obligation. With companies that process your data in our assignment, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. VAN ROSSUM GLOBAL INDUSTRIES remains responsible for these processing operations.

### **Cookies, or similar techniques, that we use**

VAN ROSSUM GLOBAL INDUSTRIES uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. VAN ROSSUM GLOBAL INDUSTRIES uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website work well and to optimize it. In addition, we place cookies that keep track of your browsing habits so that we can offer customized content and advertisements.
